**ACCESS PERMIT**

**Notice:** This permit is issued in accordance with Title 19, §1111, Vermont Statutes Annotated (19 VSA §1111), relative to all highways within the control and jurisdiction of the Town of Plainfield. The issuance of his permit DOES NOT release the Applicant or Landowner(s) from any requirements of statutes, ordinances, rules or regulations administered by other governmental agencies or the Town of Plainfield. This permit will be effective upon compliance with such of these requirements as are applicable and shall continue in effect for as long as the present land use continues. **Any change from present land use shall require a new Access Permit.** This permit is issued subject to the directions, restrictions, and/or conditions listed below, and covers only the work described in the application, and then only when the work is performed as directed. Violations are subject to the penalties set forth in Title 19 VSA §1111(j) of fines of not less than \$100, nor more than \$10,000 for each violation.
